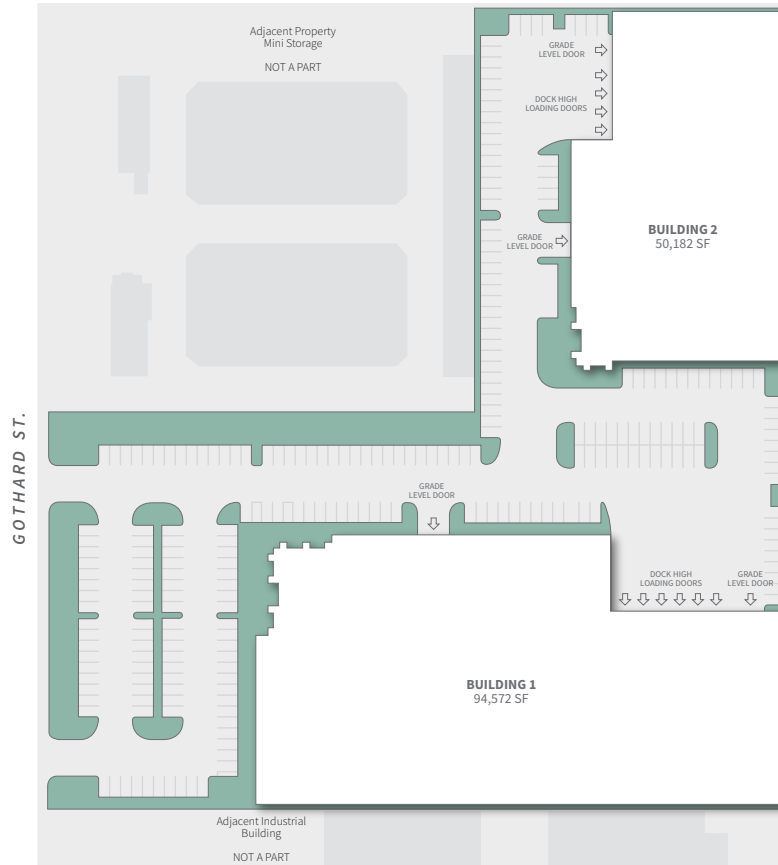
Shea Center Huntington Beach is a two building (approximately 50,182 SF and 94,572 SF) state-of-the-art industrial center located on the former site of the Randall Lumber Company in Huntington Beach. The center is built to CALGreen standards, with both buildings having the potential for fenced yards, up to 30' clear heights, multiple dock-high and ground-level loading doors and ESFR sprinkler systems.

With a planned parking ratio of 1.7:1,000, Shea Center Huntington Beach will also accommodate above average parking requirements.

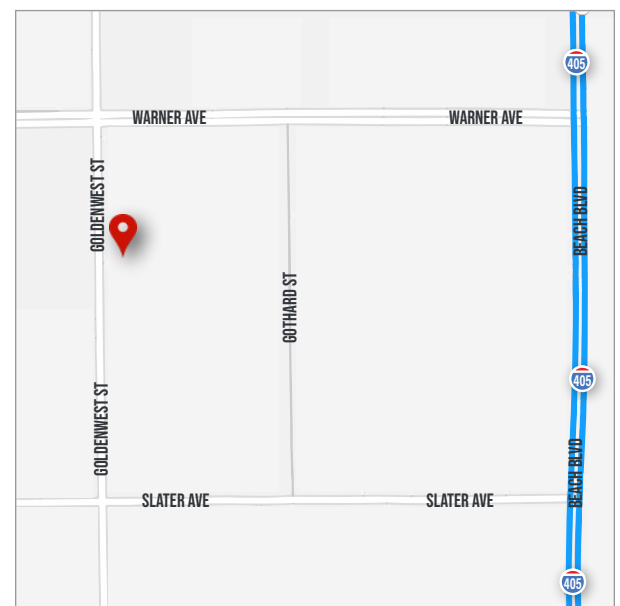

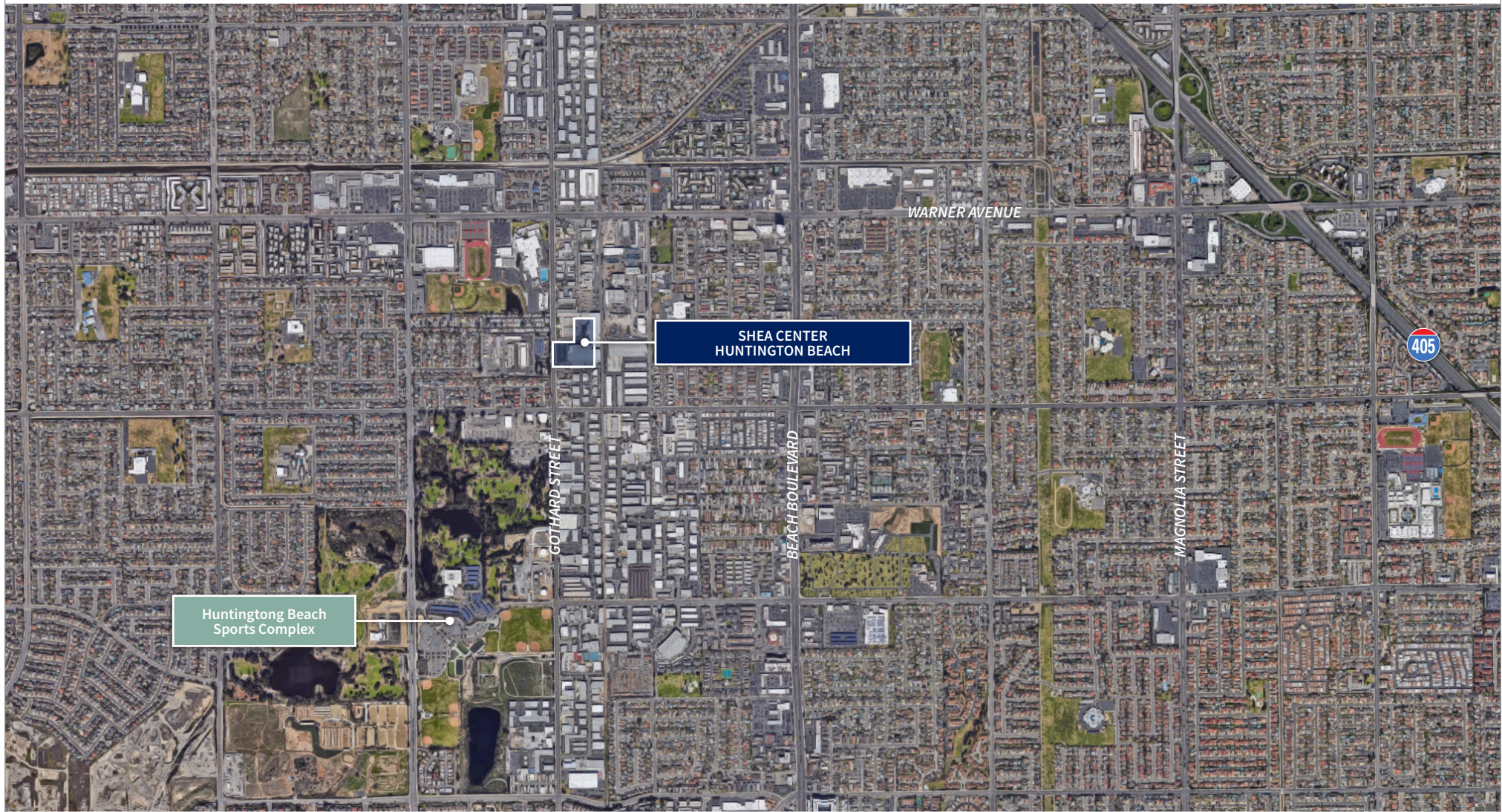

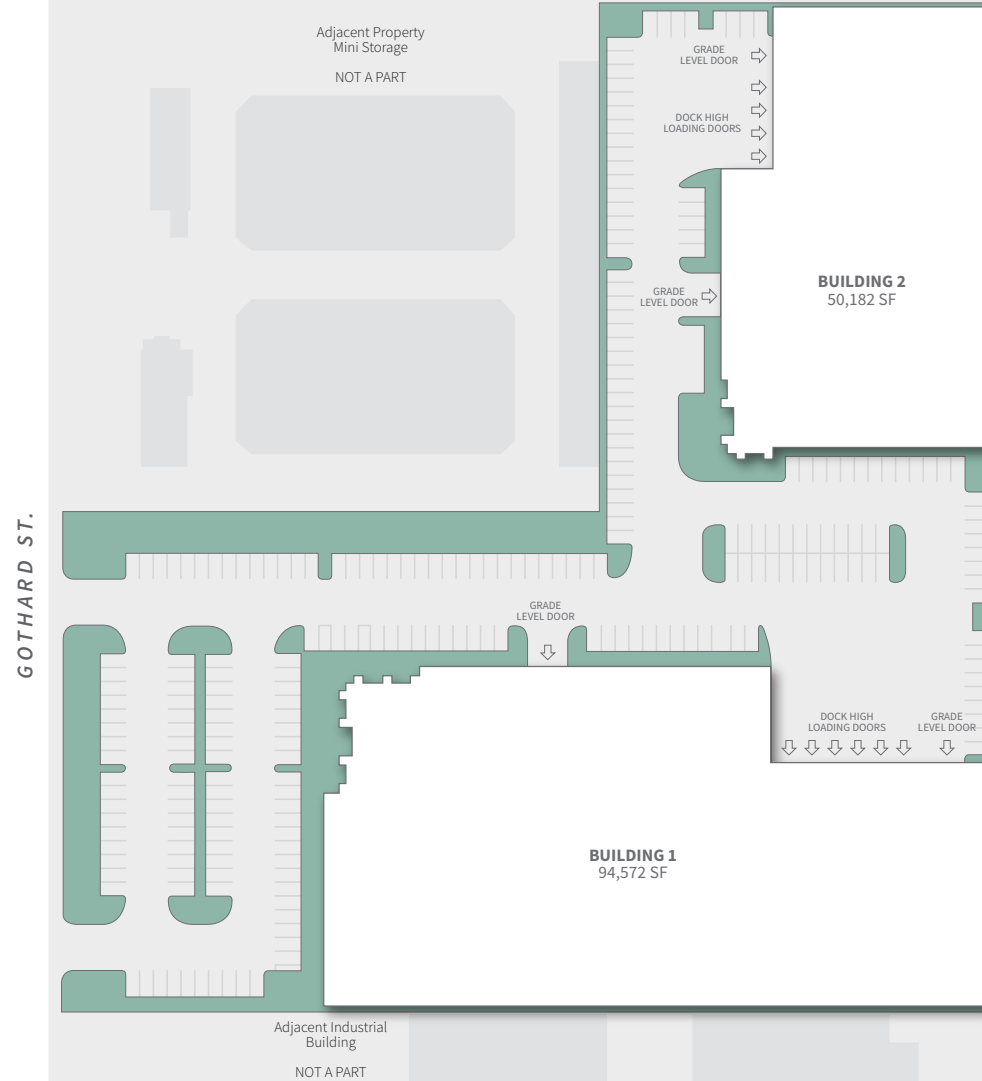
