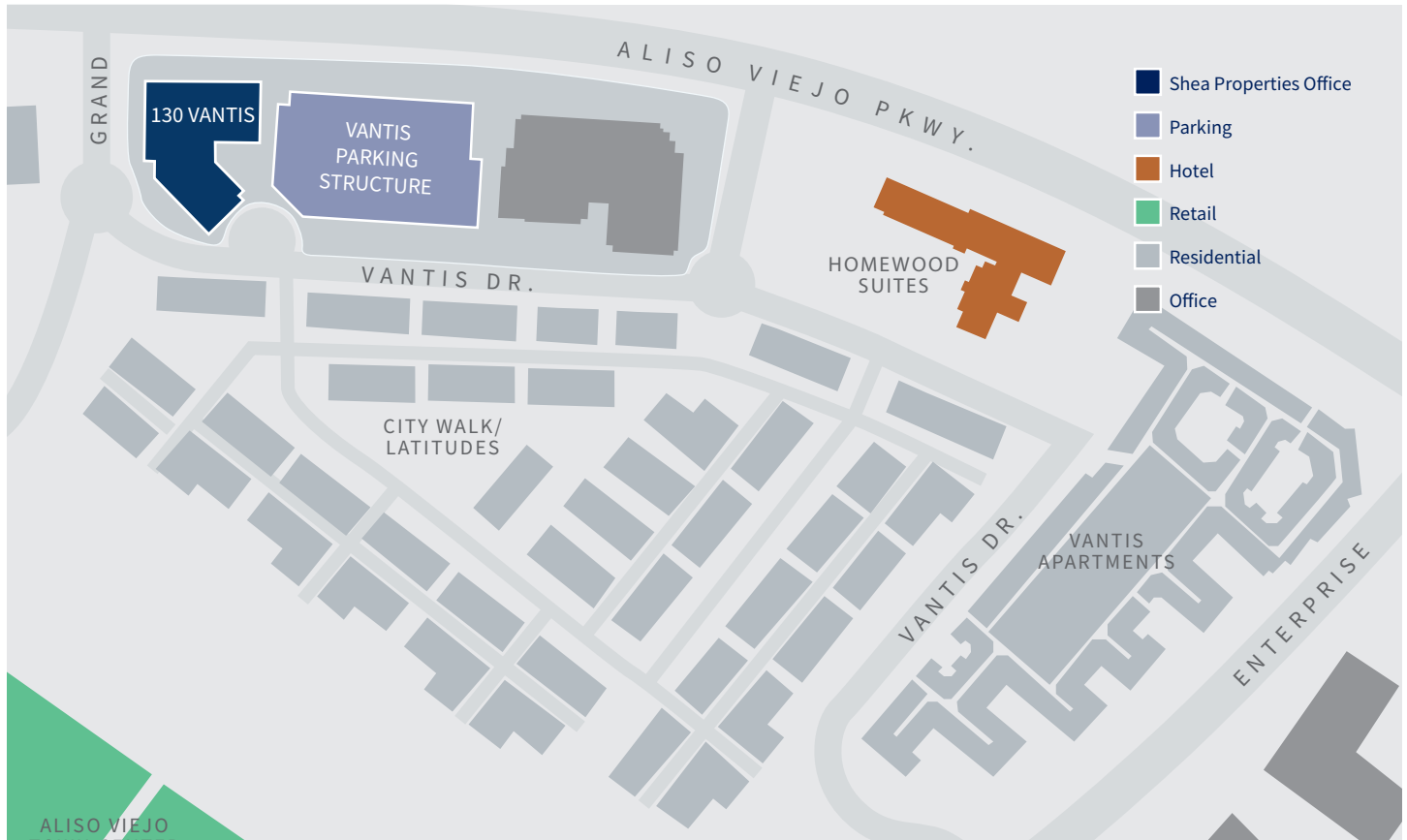

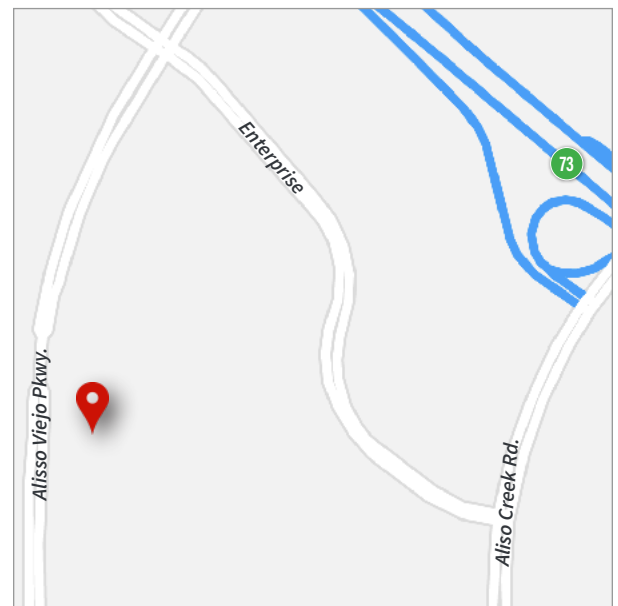

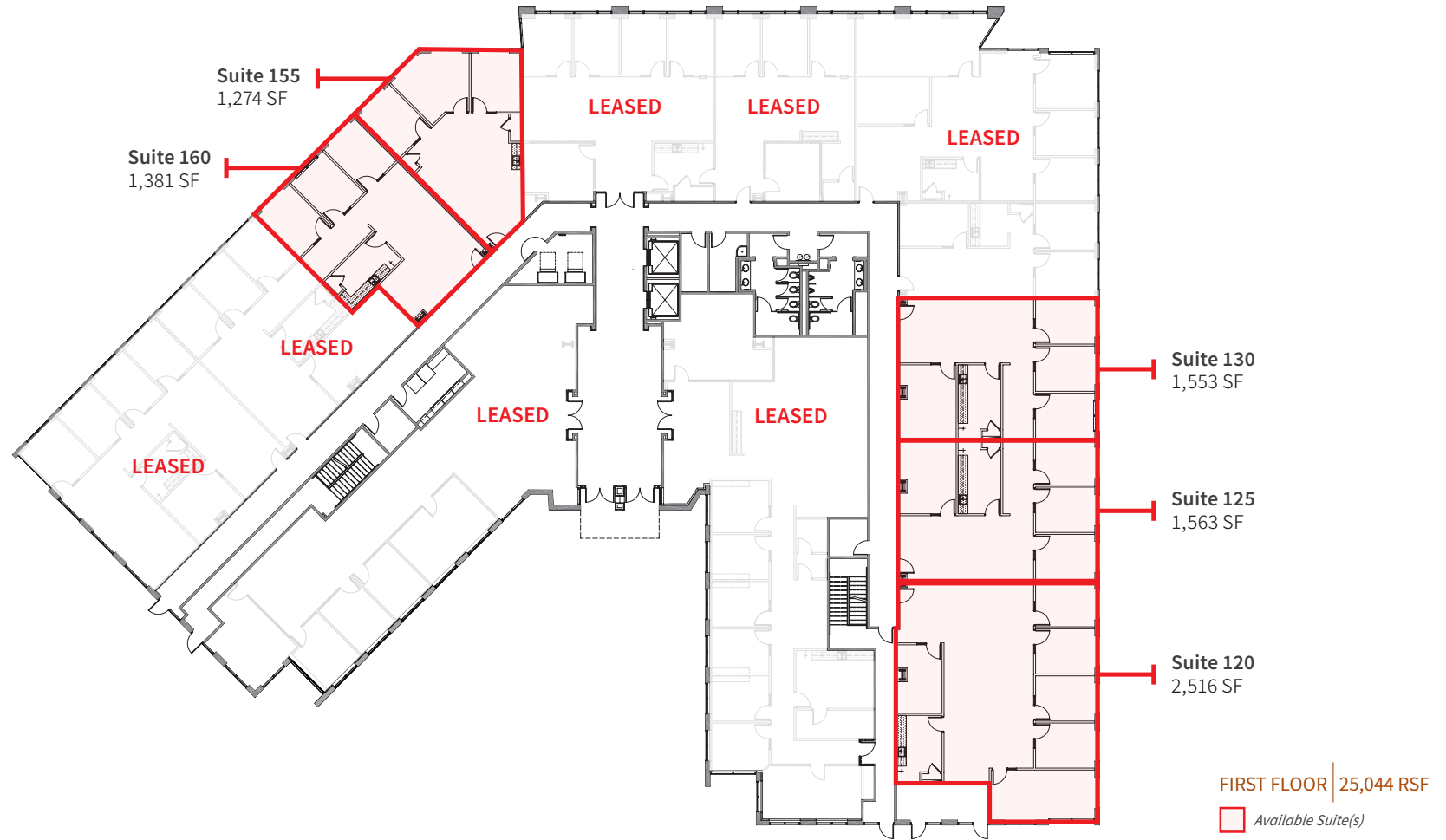
**SITE PLAN**

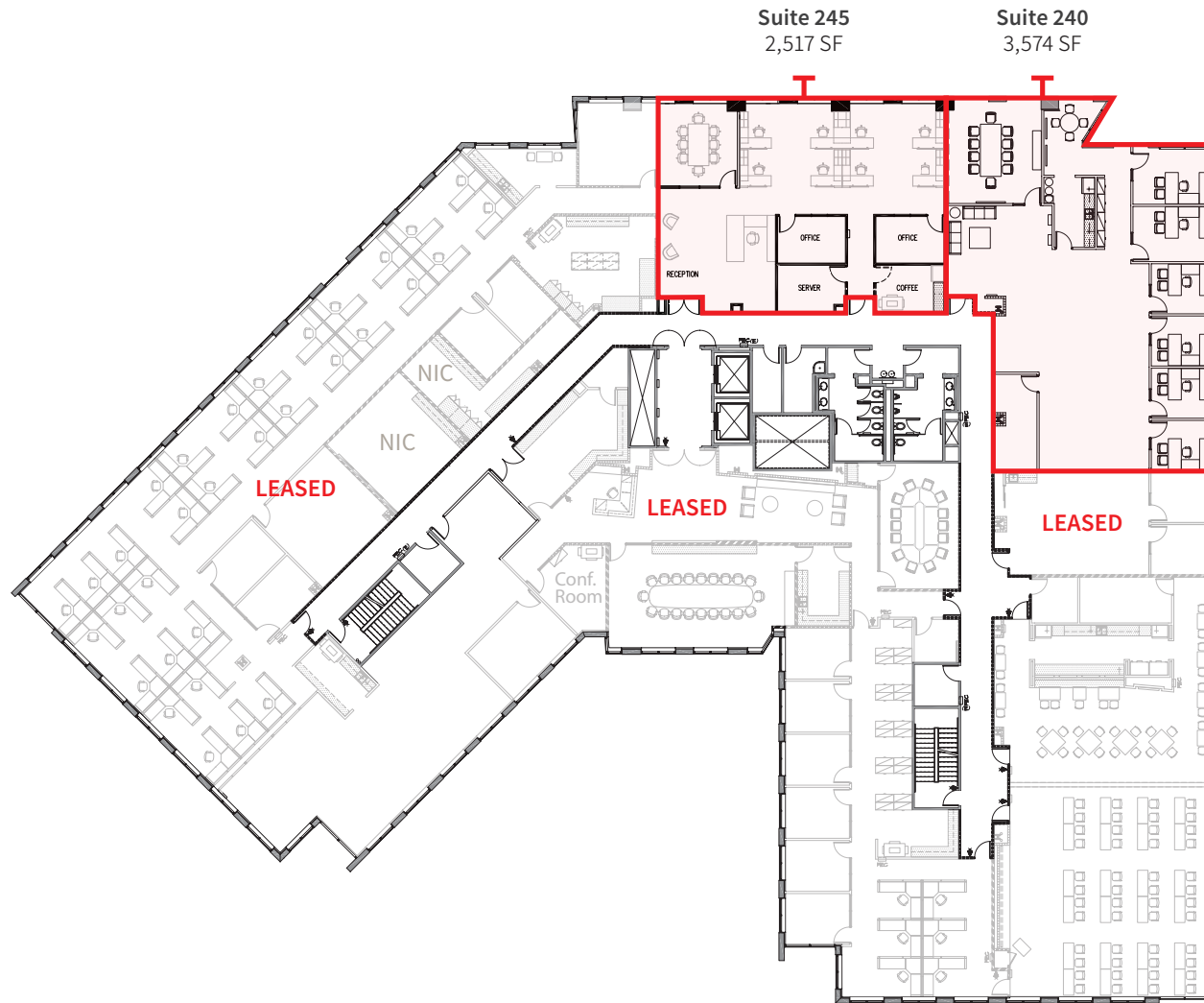
